#### Purpose of the job:

As Assistant Building Surveyor, you will be responsible for asset surveys including, adaptations and customer alterations, and determining Customer First outcomes. You will compile reports and specifications for consideration by the Surveying Team Leader.

Taking ownership of repairs, you will continually liaise with customers from inception to completion, in line with our 'Customer First' focussed approach, updating CRM cases as they progress.

You will undertake Stock Condition, Neighbourhood and Void surveys and specify works to ensure that they attain the SLH Homes Standard.

You will undertake quality inspections of works by the inhouse team and external contractors.

### **Key accountabilities:**

- 1. To undertake surveys and inspections to approve customer requests for alterations and/or adaptations. Providing information to the Asset Manager and Surveying Team Leader to enable effective decision making and approving works on completion.
- 2. To undertake surveys of void properties and prepare specifications and works orders to refurbish the property to meet the SLH Homes Standard and to undertake all necessary health and safety surveys, inspections and certifications.
- 3. To undertake surveys for communal and common areas to ensure that they remain compliant and free from defects. Raise works orders for defects and manage the works to completion.

- 4. To undertake Quality Inspections of works completed by the in-house and external contractors to ensure that the works are defect free and meet the expectations of the customer.
- 5. To undertake Stock and Component Condition Surveys and accurately record/validate data within the Asset Management System.
- 6. To undertake Stock Condition Surveys and produce reports for Right to Buy applications and Mutual Exchanges.
- 7. To liaise, collaborate and communicate with customers and colleagues about surveys and works being undertaken and updating CRM cases.
- 8. To complete Neighbourhood Surveys, raising works orders for defects, and record information in the Asset Management System and Neighbourhood Plans.
- 9. To be a proactive member of the SLH team; continually seeking to improve outcomes and develop your own skills and the performance of the team. You will seek to improve processes and ensure value for money.
- 10. To ensure that Health, Wellbeing and Safety policies and procedures are adhered to, to deliver effective and safe services and operations.
- 11. To ensure you work in accordance with legislative, regulatory and financial requirements in relation to your role at all times.
- 12. To ensure that SLH data is collected, safely and appropriately managed, reported accurately and produced in a timely fashion to aid sound decision making and that appropriate procedures, systems and processes are in place to ensure data quality and security.
